<p><b>General provisions - Information in accordance with the General Data Protection Regulation (Art 13 GDPR)</b>                  With your signature, you confirm, as an independent member over the age of 18 or as a parent or legal guardian concluding the contract, the completeness and accuracy of your data, accept the association's statutes (available at <a href="http://www.asv-wien.at">www.asv-wien.at</a>) and confirm your membership of ASV Wien. Your personal data will be processed by us exclusively for the purposes of member administration, support and information (e.g. distribution of information, newsletters, etc.) and passed on to the Austrian Swimming Association (OSV) and the Vienna State Swimming Association (WLSV) for registration. Please send a copy of your registration form (ZMR) to <a href="mailto:office@asv-wien.at">office@asv-wien.at</a> (required for registration with the OSV/WLSV). Please inform us of any data changes within 2 weeks. Only fully completed forms entitle you to participate in training. When you join, a contractual relationship is established with the Arbeiter Schwimm Verein Wien, which is also the legal basis for data processing. Data is only transferred within our organization. No data is transferred to a third country or an international organization. Your data will be processed as long as your membership is valid or as long as there are still claims arising from your membership and unless longer retention periods are prescribed by law. You have the right to information, rectification or erasure, as well as a right to restriction of processing, to object and to data portability. In the event of an assumed discrepancy in the protection of your personal data, you have the right to lodge a complaint with the Austrian data protection authority (<a href="http://www.dsb.gv.at">www.dsb.gv.at</a>).</p> <p><b>Deregistration</b>                  Membership is concluded for an indefinite period. Resignation must be declared with a notice period of one month to the end of each quarter of the respective year. Notice of termination must be sent in writing by email (<a href="mailto:office@asv-wien.at">office@asv-wien.at</a>) or post (Floridsdorfer Hauptstraße 29/5, 1210 Vienna) to the Executive Board. If the notice is sent late, it shall not take effect until the next resignation date. The membership fees must be paid by the end of the membership. In the case of unpaid fees, parents are liable for their children.</p> <p><b>Liability/duty of care</b>                  In their own interest, all active participants should undergo an annual health check with a doctor. Liability due to illness cannot be accepted. The trainer's duty of supervision begins and ends at the edge of the pool. Changing clothes, hygiene and other procedures are the responsibility of the parent or guardian.</p> <p><b>Photo/reporting</b>                  I hereby expressly agree that, as an independent member over the age of 18 or as a parent or legal guardian concluding the contract, photos of and with me or of my child in connection with mine or my child's membership of ASV Vienna may be uploaded to freely accessible websites, social networks such as Facebook or other Internet providers and that reports may also be made about me or my child.
